Fuel Economy

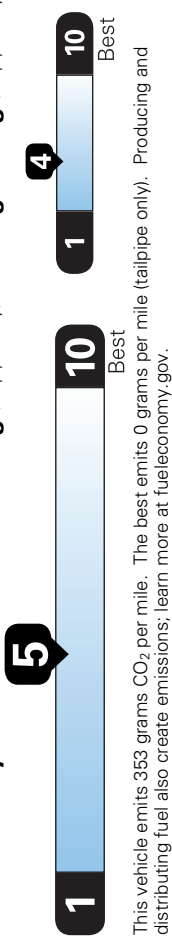

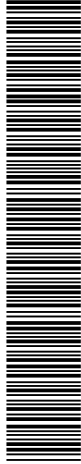
